NOTICE INVITING TENDER

Sealed Tenders are hereby invited from experienced suppliers/firms for Supply, Installation, Testing and Commissioning of IP Based CCTV Camera's and other required accessories in Institute Boy's Hostel (**Annexure-1**). The Technical bid shall be opened on 19/01/2026 at 11:00 AM and the financial bid shall be opened on 20/01/2026 at 11:00 AM in the presence of the bidder/supplier or their authorized representative who wishes to be present. Terms & Conditions:

1. Technical Bid & Financial Bid shall be submitted in separate sealed envelopes. The word 'Technical Bid' or 'Financial Bid' should be written on the outer sealed envelope. Both bids should be further enclosed in the outer sealed bigger envelope and the words '**Limited Tender for “Supply, Installation, Testing and Commissioning of IP Based CCTV Camera’s and other required accessories in Institute Boy’s Hostel” at Jawaharlal Nehru Govt. Engineering College Sundernagar, Distt. Mandi (H.P.)**' must be written on the top of the outer envelope.
2. Financial bids shall be opened only when the bidder qualifies in the Technical bid.
3. The firm should have valid GST and PAN, copies of which should be enclosed.
4. All Tenders/bids must be accompanied with an **Tender Cost of Rs 300/- (Rs. Three Hundred only) (Non refundable) and Earnest Money Deposit (EMD) amounting to Rs. 10000/- (Rs. Ten Thousands only) (Refundable)**. The Tender Cost shall be in the form of DD from any nationalized bank in favour of Director-cum-Principal, J. N. Govt. Engg. College, Sundernagar, Distt. Mandi (H.P.) Pin- 175018 and EMD shall be attached in the shape of Accounts Payee duly pledged fixed Deposit Receipts in the favour of Director-cum-Principal, Jawaharlal Nehru Govt. Engineering College Sundernagar, Distt. Mandi (H.P.)
5. The Tenders/Bids not accompanied by EMD or incomplete in any respect will be rejected outrightly.
6. The successful supplier has to furnish the performance security at the rate of 5% of the contract value in the form of account payees duly pledged fixed deposit receipts drawn in the favour of the Director-Cum-Principal, Jawaharlal Nehru Govt. Engineering College Sundernagar, Distt. Mandi (H.P.)
7. The offer shall be inclusive of all taxes, commissioning, installation and training whenever required.
8. A certificate to this effect that you are the manufacturer of the required items/Authorized distributor for the manufacturer must be submitted and attached in the Technical bid.
9. The Tender/Bids will be opened on the date and time as mentioned in the tender document and in the presence of bidders if they wish to be present. However, undersigned reserved the right to change the date, time and venue of the receipt of the tender without assigning any reason.
10. Conditional Tenders/Bids and Tender/Bids not submitted on the prescribed tender form are liable to be rejected.
11. The quantity of items can be increased or decreased before placing the order.
12. The supply order shall be issued to the eligible bidder on the availability of funds.
13. 100% payment will be released within one month after the satisfactory installation/testing of machinery & equipments in the concerned lab/center.
14. The Warranty/Guarantee shall be effective for the period of at least 36 months from the date of the actual installation of CCTV Cameras and other required accessories at the actual location
15. Director-cum-Principal reserves the right to accept or reject all or any of the bids received without assigning any reason thereof.
16. Limited tender received in open condition after due date & time will be summarily rejected.
17. It will be presumed that all the above conditions are acceptable to the bidders applying through the limited tender.
18. If the date of opening the tender/quotation happens to be holiday, the tenders/quotation will be opened on the next working day at the same time.
19. Tenders/quotations received through mail, telegraph, fax, conditional tenders/quotation and without Tender Cost and Earnest Money shall not be accepted.

20. Director-cum-Principal may also appoint a 'Negotiation Committee' if required.
21. The bidder will be responsible for damage or loss in transit and goods broken within 30 days from the date of notice thereof.
22. The bidder/supplier shall submit undertaking stating that their firm is not blacklisted by any Central/ State Government/ agency of Central/ State Government of India or any other country in the world/ Public Sector Undertaking/ any Regulatory Authorities in India or any other country in the world for any kind of fraudulent activities.
23. The bidder/supplier shall submit undertaking stating that the prices quoted Vide Quotation No. _____ dated: _____ against Tender No: _____ dated: _____ for (name of item) are best and minimum and we have not quoted the same on lesser rates than those being offered to any customer nor we will do till the validity of offer or execution of Purchase Order.
24. The rate quoted shall be inclusive of GST and any other tax and no future increase in rate will be allowed. The gross total value wise evaluation will be done.
25. The bidders should strictly quote the items according to the specifications mentioned in the tender document. Any deviation from the required specifications shall not be accepted.
26. The complete bid should reach in the office of the undersigned on or before the due date and time.
27. The bid should accompany ITR of previous 3 financial years.
28. The bidder can attach copy of the supply order of similar type of items from any reputed govt. institutes (if any).
29. The bid offered by the bidders must be valid for six months from the date of opening the tenders.
30. The bidders must stamp and sign each paper submitted along with their bids.
31. The rates quoted should be F.O.R. destination at Jawaharlal Nehru Govt. Engineering College Sundernagar, Distt. Mandi (H.P.).
32. All disputes shall be settled within the jurisdiction of Session Court, Sundernagar Mandi (H.P.).
